

Terms and Conditions of Purchase & Our Privacy Policy

Terms & conditions of Purchase

1. ParkMagic Mobile Solutions Ltd. (ParkMagic) processes parking reservations on behalf of Newlands Cross Hotel (hereafter "Bewley's Hotel Dublin Airport And / or Bewley's Hotels.") which means ParkMagic does not set the prices and/or availability of parking spaces. All purchases are subject to credit or Debit card authorisation and billing address verification which may take place after initial confirmation has been given.

For the absolute avoidance of all doubt, it is agreed that no contract shall exist between you the Customer and ParkMagic

2. Occasionally, for reasons outside of the control of ParkMagic bookings may be rescheduled by Bewleys. Should this occur, we will endeavour to contact you either by phone and/or e-mail with the contact details you provided at the time of booking. You will be refunded the full amount paid at the time of your original booking via the method of payment you used to make that booking.

3. Bookings are issued subject to the Rules and Regulations of the Bewleys Car Park . It is your responsibility to understand and accept the policies of the Car Park you choose to make a booking with. For your convenience, and without obligation, ParkMagic provide links to and/or a copy of these terms on this payment site.

4. Please check your bookings before confirming payment, as mistakes cannot always be rectified and may be subject to a rebooking fee.

5. We regret that bookings cannot be exchanged or refunded after purchase save where a booking cancellation is made by the Car Park operator or a cancellation request is made in accordance with the relevant terms and conditions.

6. If a purchased booking is re-sold or transferred for profit or commercial gain by anyone other than the ParkMagic or Bewleys it will become voidable and the holder may be refused entry to the Car Park. ParkMagic reserves the right to cancel any bookings advertised or published in any manner with the intent to resell for profit or commercial gain.

7. Should a booking holder remain parked in the car park for longer than the time originally booked and paid for the booking system will automatically calculate the cost of the overstay and debit the payment card used in the original booking. The rates charged for any overstay shall be those that prevailed at the time of the original booking.

8. Should you, as a booking holder, arrive early to the car park in which you are booked you may, if spaces are available, be granted admission by the booking system. In this event you the booking system will automatically calculate the cost of the additional time parked and debit the payment card used in the original booking. The rates charged for shall be those that prevailed at the time of the original booking. Please note that neither ParkMagic nor the car park operators on whose behalf we operate the service can guarantee the availability of spaces should you arrive at your booked parking facility earlier than the prebooked time.

9. Should you wish to cancel your booking more than 24 hours before the scheduled booking start time a cancellation fee of €8 will apply (which is the equivalent to one days parking at standard prices). No refund will be available for a cancellation made less than 24 hours before the scheduled booking start time, save in exceptional circumstances where we receive a request for refund in writing.
